Grading criteria: Business Management and Organization

Business Management and Organization is a broad discipline where a general progression cannot be proven. There are however several parallel parts within the subject where there is an obvious progression. For this reason it is important to specify the grading criteria for each part of the subject area and also in each separate course syllabus. This compilation should therefore be considered as a temporary solution until more specified grading criteria have been formulated for each course syllabus. To obtain the grade E or above all of the intended learning outcomes should be examined and each part should at least fulfill the requirements for the grade E. High marks are distributed according to the following.
