## Grading Criteria: Computer Engineering

Computer Engineering and Computer Science are broad disciplines where a general progression cannot be proven. There are however several parallel parts within the subject in which there is an obvious progression. For this reason it is important to specify the grading criteria for each part of the subject area and also in each separate course syllabus. This compilation should be considered a temporary solution until more specific grading criteria have been formulated for each course syllabus. To obtain the grade E or above all of the intended learning outcomes should be examined and each part should at least fulfill the requirements for the grade E. High marks are distributed according to the following.
